IAF Plan Crash near Bhaderia Khera Village in Lucknow

250. SHRI PRABHAKAR RAO KALVALA; Will the PRIME MINISTER he pleased to state:

- (a) whether an IAF Plane crashed near Bhaderia Khera village in Lucknew District on the 9th January, 1991.
- (b) if so, what were the reasons of the accident;
- (c) what is the estimated loss of life and property;
- (d) whether any compensation has since been paid; and
- (e) what are the details of the inquiry conducted by Government in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI LALIT VIJAY SINGH): (a) Yes, Sir. An JAF aircraft crashed near village Bhadauria Khera in Lucknow District on the night of 8th January 1991.

- (b) The accident was most probably caused dry to spatial disorientation of the pilot.
- (c) The pilot and navigator of the aircraft were killed. The aircraft was completely destroyed. There was no injury to civilians. Some standing crops and trees were damaged.
- (d) For the damage to private property, compensation claims are being processed and due compensation will be paid to the individuals as per rules.
- (e) The Court of Enquiry which was instituted has concluded that the accident was most probably due to spatial disorientation of the pilot while flying in dark night conditions.
