- (d) to (f) Even though the producer was requested to make the necessary changes in the two episodes submitted by him, according to Doordarshan, the programme has not come up to their expectation and is yet to be approved finally. Therefore, the date of telecast is yet to be decided.

Media Workshop and commissioned by Doordarshan could not be telecast during the 1989 pre-elections days as its telecast at that time would have infringed the guidelines issued by the Election Commission.

(b) and (c) Taking into account the participants in the programme and the specific events which it deals with, the programme appears dated and hence Doordarshan does not propose to telecast it at this stage.
