Capacity utilisation of Hindustan Cables Ltd.

*278. SHRI KRISHNA KUMAR BIRLA: Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that the capacity utilisation in Hindustan Cables Ltd. fell substantially during 1990;
- (b) if so, what is the percentage of fall in the capacity utilisation of HCL during 1990 and what are the reasons therefor;
- (c) what is the estimated loss suffered by HCL as a result thereof; and
- (d) what measures have been taken by Government to improve its capacity utilisation in 1991 to minimise the losses?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI P. K. THUNGON): (a) and (b) During 1989-90 and 1990-91, the fall in capacity was 27% and 38% respectively, mainly due to shift in demand pattern of traditional products, severe competition and power restrictions.

- (c) The loss suffired by HCL during 1990-91 is estimated at Rs. 617 crores.
- (d) With a view to improve capacity utilisation, Government have approved schemes for conversion of dry core cable capacity to jelly filled cable capacity, manufacture of joining kits and diversification into allied fields.
