Deep sea fishing vessels in Vishakhapatnam

PADMANA-1588. SHRI MENTAY Will the Minister of FOOD BHAM: PROCESSING INDUSTRIES be pleased to state:

(a) the number of deep sea fishing vessels presently fishing at Visakhapatnam;

(b) the number of deep sea fishing vessels lying idle due to S.C.I.C.I. actions;

(c) whether any rehabilitation proposals have been cleared by Empowered Committee:

(d) the number of companies whose proposals are pending before the Empowered Committee; and

(e) what are the reasons for delay?

THE MINISTER OF STATE (INDE-PENDENT CHARGE) OF THE MINI-STRY OF FOOD PROCESSING INDUS-TRIES (SHRI GIRIDHAR GOMANGO): (a) There are 179 Indian owned deed sea fishing vessels; out of which only 170 are operational. The total number of deep sea fishing vessels at present operated from Vishakhapatnam is about 160.

(b) Due to legal action taken by the Shipping Credit & Investment Company of India Ltd., 10 vessels have been lying idle; out of which nine are at Vishakhapatnam.

(c) No proposal of rehabilitation has been submitted to the Empowered Comthe basis of mittee on Rehabilitation Scheme announced by the Shipping Credit & Investment Company of India Ltd. on 4-4-1991. However, out of 17 proposals considered by the Committee of Joint Scretaries in the Ministry of Finance, 16 cases have been cleared for rehabilitation and one proposal has been rejected due to technical reasons.

(d) No proposal is pending with the Empowered Committee or with the Committee of Joint Secretaries in the Ministry of Finance.

(e) There is no delay in consideration of full and complete proposals for rehabilitation.

Average availability of edible oil and its , allocation to various States..

(a) what is the average availability of edible oil including palmolein in the country:

(b) what is the criteria for allocation of palmolein to the various States;

(c) the amount of edible oil allotted to Maharashtra during the months of December, 1990, January, 1991 and April, 1991 to June, 1991;

(e) whether Government propose to maintain the supplies @ 26 per cent of the all India allocation; if not, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES AND PUBLIC DISTRIBUTION (SHRI KAMA-LUDDIN AHMED); (a) The net availability of edible oils in the country from all domestic sources and imports effected so far (including Palmolein) during the Current Oil Year 1990-91 (November-October) is estimated to be 55.71 lakh MTs.

(b) The allocation of imported edible oils to States/UTs is decided based on factors such as local availability of indigenous oils, realistic demand of the State UTs, availability of imported edible oils with the Government, pace of lifting etc.

(c) No regular allocation of imported edible oils including to state/UTs Maharashtra has been made during the mtnths of December, 1990. January, 1991 and April, 1991 to June, 1991. However, an adhoc allocation of 600 MTs of Palmolein has been made to Maharashtra in June, 1991, out of the residual stock of edible oils with STC.

(d) and (e) The demand of States could not be met on account of suspension of import of edible oils due to severe foreign exchange constraints.

Approval to MRF to maunfacture precured traders

(a) whether it is a fact that Government have granted approval to MRF for setting up a project to manufacture precured treads despite the fact that this item is reserved for the small scale sector under the industrial policy;

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI P. J. KURIEN): (a) M/s. M.R.F. Ltd., have been granted a Letter of Intent for the manufacture of 4000 tonnes per annum of precured treads (for tyres) at their existing industrial undertaking at Ankanapally Madikunda Tehsil Sadasivapet, District Medak in the State of Andhra Pradesh. Manufacture of precured tread by cold cure process has been specifically excluded from the reservation for small scale sector.
