MARGARET ALVA): (a) From among the atomic power projects presently under construction, commissioning of the second unit of Narora Atomic Power Project has been delayed for a period exceeding one year at the end of 1990.

(b) The two unit project at Narora (of which the first unit is already commissioned) was Rs. 399.64 crores in 1983. The latest cost estimate is Rs. 645 crores plus interest during construction. No further increase in cost is anticipated.

(c) Yes, Sir.

(d) The second unit at Narora is scheduled to achieve criticality by end August, 1991 and commercial operation in January 1992 as per the latest revised schedule. All activities are being closely monitored with a view to achieve the above schedules.
