Setting up of aero-space department

1583. DR. RAJA RAMANNA: Will the Minister of DEFENCE be pleased to state whether Government propose to set up a full-fledged AERO-SPACE Department, in view of the large commitments of Missile and Aircraft development programmes of the country?

THE MINISTER OF DEFENCE (SHRI SHARAD PAWAR): The need for ordinated efforts in aero-space including design, development and production missiles and aircrafts has been felt by the Government. Various steps have been taken to strengthen close interaction coordination amongst various agencies working in these areas. However, there is no concrete proposal under consideration by the Government at present to set up a full-fledged Aero-Space Department.

Off-Itading of production to private sector

1584. DR RAJA RAMANNA: Will the Minister of DEFENCE be pleased to state whether Government propose to off-load production of some materials, now being done by the D.G.Q.A. to other better equipped inhoratories in the Government and private sector to assure quality?

THE MINISTER OF DEFENCE (SHRI SHARAD PAWAR): The role of D.G.Q.A. is to assure quality of defence stores and not production of materials.

The D.G.Q.A. laboratories are, by and large, adequately equipped for quality assurance. However, the facilities available in other recognised laboratories are also being used as necessary and expedient.

D.G.Q.A. quarters in Bangalore

1585. DR. RAJA RAMANNA: Will the Minister of DEFENCE be pleased to state whether the D.G.Q.A. has set up a large number of living quarters in the city of Bangalore which have been in an unfinished state for several years?

THE MINISTER OF DEFENCE (SHRI SHARAD PAWAR): Yes, Sir, 550 living quarters of various types are under construction in the city of Bangalore since September, 1987.
