श्री मंत्री (श्री शरद पवार) : (क) जी हाँ। वर्ष 1990-91 में दानापुर छावनी बोर्ड ने 6,86,292/- रुपये की लागत से वार्ड संख्या 1,2,3, तथा 4 में सड़कों की मरम्मत की थी और सड़कों का पुनर्निर्माण किया था।

(ख) से (ग) जी, नहीं। दानापुर छावनी बोर्ड ने 1975 में आई बाढ़ के बाद वार्ड संख्या 5 और 6 में कुछ सड़कों की मरम्मत की थी। धन की कमी के कारण वे सड़कों की आवश्यक मरम्मत नहीं कर सके। इनमें वार्ड संख्या 5 तथा 6 की सड़कें भी शामिल हैं। तथापि, वार्ड संख्या 5 और 6 में बाढ़ से प्रभावित गलियों (लेनों) की मरम्मत कर दी गई है।
