MCTVT passed Trade Apprentices of the 20th Batch have not been absorbed in the Ordnance Factories at Ichapur whereas the NCTVT passed Ex-Trade Apprentices of the 22nd Batch have been absorbed in some of the other urdnapre Factories.

(c) It has not been possible to maintain inter-batch parity among the Ex-trade Apprentices in the matter of their absorption which depends on the vacancies available for filling, which would vary from factory to factory and trade to trade. However, based on the production re-quirement of the factory about 150 Trade Apprentices have been recruited recently in the Rifle Factory, Ichapore covering majority of the NCTVT passed Ex-Trade Apprentices of the 20% Batch,
