Supply of rice and wheat at subsidised cost

1579. SHRI S. K. T. RAMACHANDRAN: Will the PRIME MINISTER be pleased to state:

(a) the norms for supplying rice and wheat at subsidised rate through public distribution system; and

(b) whether Government propose to supply foodgrains at subsidised rates only to those who are below the poverty line?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES AND PUBLIC DISTRIBUTION (SHRI KAMALUDDIN AHMED): (a) The Public Distribution System is universal in nature, and does not distinguish the beneficiaries on the basis of income etc. However, under a Scheme for areas covered by Integrated Tribal Development Projects (ITDP), specially subsidised foodgrains are distributed to the population living therein.

(b) There is no such proposal at the present.

Combating economic offences by modifying Essential Commodities Acts

1580. SHRI S. K. T. RAMACHANDRAN: Will the PRIME MINISTER be pleased to state whether Government propose to take strong measures by suitably modifying the Essential Commodities Acts, incorporating heavy punishments to hoarders, black marketeers, profiteers and those who produce and sell sub-standard goods, so as to combat effectively the economic offences and anti-social activities?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES AND PUBLIC DISTRIBUTION (SHRI KAMALUDDIN AHMED): The Essential Commodities Act contains comprehensive provisions for checking and punishing such malpractices. They were made more stringent with the enactment of Essential Commodities (Special Provision) Act, 1981 with a view to providing more effective deterrents against hoarding and black-marketing. There is no proposal to amend the Act.
