In order to achieve the objective expeditiously, the Action Plan will be implemented in phases which envisages return and rehabilitation of migrant families in areas where clusters of migrant houses are available in villages/mohallas in the Kashmir Valley districts with sizeable Kashmiri population and where security is already being provided. Out of first phase of Rs. 43.94 crores for 2122 families in 1065 houses in selected clusters, State Government has, to begin with, identified 166 houses forming 15 clusters in Srinagar and Budgam districts which are considered safe for the return of their Kashmiri migrant owners. State Government is contacting owners to obtain their consent for returning on the basis of a package announced by the State Government.

3106.SHRIMAU RICE KUJUR: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) what was the population of Scheduled Castes and Scheduled Tribes in 1951 and their percentage of total population;
- (b) the State-wise and year-wise other communities and their population included in the Scheduled Lists of the Constitution from 1951 to 2001;
- (c) whether it is a fact that population of SC and ST at present is higher than reservations provided for various purposes;
- (d) if so, whether Government propose to provide higher representation in Parliament, State Assemblies, Panchayats and services in proportion to their population; and
- (e) if so, by when it will be provided and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI CHENNAMANENI VIDYASAGAR RAO): (a) and (b) The details of State-wise and census year-wise (1951 -1991) population of Scheduled Castes, Scheduled Tribes and Other communities (Non SC/ST) and their percentage to total population are given in Statement I to V (*See* below). The population of Scheduled Castes and Scheduled Tribes as per the 2001 Census are not yet available.

(c) to (e) As per 1991 Census of India the percentage of Scheduled Castes and Scheduled Tribes in the country, excluding Jammu and Kashmir, was 16.48 and 8.08 respectively. Percentage of reservation for SCs and STs in services

under the Central Government in case of direct recruitment on all India basis by open competition is 15 per cent and 7.5 per cent respectively. In case of direct recruitment on all India basis otherwise than by open competition reservation for SCs and STs is respectively 16.66 per cent and 7.5 per cent. In case of direct recruitment to Group C and D posts which normally attract candidates from a locality or a region, percentage of reservation for SCs and STs is generally fixed in proportion to the population, of SCs and STs in the respective States/UTs. In case of promotion, 15 per cent posts are reserved for SCs and 7.5 per cent for STs, provided the element of direct recruitment, if any, does not exceed 75 per cent.

It is stated that reservation for Scheduled Castes, Scheduled Tribes and OBCs in services under the Government of India is already 49.5 per cent and 50 per cent in case of direct recruitment on all India basis by open competition and on all India basis otherwise than by open competition respectively. Under the circumstances revising the percentage of reservation for Scheduled Castes and Scheduled Tribes as per their population, is neither contemplated under Article 16(4) of the Constitution nor feasible, as such revision would make the total reservation for SCs/STs and OBCs in excess of 50 per cent.

Constitution (Ninety-first Amendment) Bill, 2000 was introduced in the Lok Sabha on 27.11.2000, seeking to extend the existing constitutional embargo on undertaking fresh delimitation of electoral constituencies upto the year 2026 AD and simultaneously to undertake readjustment and rationalization of constituencies in the States, without altering the number of seats allotted to each State in the House of the People and Legislative Assemblies of the States, including the Scheduled Caste and the Scheduled Tribe constituencies, on the basis of the population ascertained at the census for the year 1991 as also to re fix the number of seats reserved for the Scheduled Castes and the Scheduled Tribes in the House of the People and Legislative Assemblies of the States on the basis of the population ascertained at the census for the year 1991, was passed by the Lok Sabha on 21.8.2001 and by the Rajya Sabha on 23.8.2001. The said Bill is now in the process of being ratified by the State Legislatures before receiving the assent of the President under the provisions of the Article 368 of the Constitution. Pursuant to its enactment the Government will further bring a legislation which will provide for setting up of an authority to carry out the purposes of the aforesaid Constitution Amendment Bill.

As regards reservation of seats in the Panchayats the same is governed by Article 243 D (1) of the Constitution of India.
