THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI M. ARUNACHALAM): (a) to (d) A Government servant on retirement from service is eligible to retain the accommodaiion for a period of 4 months on payment of normal rent under provisions of SR-317-B-11(2). Thereafter he may be permitted furthe,- retention for a period of another 4 months on medical or educational grounds on payment of twice the flat rate of licence fee subject to fulfilment of certain conditions under proviso to SR-317-B-22. For the period of stay beyond 8 months, the officer is liable to be char-fed damages at the prescribed rates.

Officers who are re-employed after retirement on a full-time basis in an eligible office withing the concessional period are eligible for retention of the accommodation in their occupation under provisions of SR-317-B-11(4), Such cases are considered under the rules and the allotments are regularised in their name, if the officers are eisible. Otherwise they are liable to be evicted and damages are levied as per rules for the period of overstay.

The officers who are employed on part time basis or as Consultants after retirement are not alisible for retention of accommodation and action in their case is taken accordingly.

THE MINISTER OF STATE OF THE MINISTRY OF FOOD (INDEPENDENT CHARGE) (SHRI TARUN GOGOI): (a) and (b) During the last three years i.e. 1987-88 to 1989-90 (Oct.—Sept.), 36 Letters of Intent have been issued for establishment of new sugar factories in Cooperative Sector in Maharashtra State. The names and addresses of these factories are at Statement. [See Appendix 159,

Annexure No. 54]. Out of these; the financial institutions have so far provided financial assistance to 9 cooperative sugar factories.

- (d) The then chief Minister in his letter dated 8th January, 1991 had suggested, interalia, that more funds may be placed at the disposal of National Cooperative Development Corporation (N.C.D.C.) for meeting the share capital needs of new cooperative sugar factories.

Daring 1991-92, Rs. 30.00 crores 'have been provided to NCDC under the Centrally Sponsored Scheme for share capital participation, as against Rs. 8.00 crores provided during 1990-91.
