

### Filling up of vacancies of Stenographers Grade II in Office of E.P.F. Organisation

1821. SHRIMATI SATYA BAHIN: Will the Minister of LABOUR be pleased to state:

(a) whether it is a fact that many posts of Stenographers Grade II are lying vacant in the Central Office of the Employees Provident Fund Organisation;

(b) whether it is also a fact that the posts reserved for Scheduled Castes/ Scheduled Tribes were filled by promoting the general quota candidates in violation of Government instructions in this regard; and

(c) if so, what action Government propose to take to fill up the vacant posts of Stenographers Grade II by promoting the Scheduled Castes/Scheduled Tribes candidates and what action Government propose to take against the authorities responsible therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI PABAN SINGH GHATOWAR): (a) No, Sir. Two posts of Stenographer (Grade-II) which fell vacant recently are in the process of being filled.

(c) if so, the outcome of the investigation giving the detail of the persons who had a hand in the leakage of the question papers and the action taken against them?

(b) Yes, Sir. Three papers were cancelled. Investigation was entrusted to the Crime Branch of Delhi Police.
