Hospital was taken by the Directorate of Estates on receipt of intimation of Vacancy from CPWD Enquiry Office on the presumption that the quarter fell in General pool. The quarter was also simultaneously allotted to an employee of Govt, of India Press, Minto Road by the Govt, of India Press from the Press

Pool. After realising that the house belonged to the Press Pool, the allottee from the Government of India Press was allowed to occupy the house. As such, the question of taking action against any of the officer of the Directorate of Estates do mot arise, since it was a bonafied mistake.

New infra-urban projects and suburb* Railway projects in Bombay
