for production of trout seed and grant-inaid to Himachal Pradesh Krishi Vishwa Vidyalaya, Palampur fo revolving suitable pisciculture techniques for high altitude waters. The total outlay during 1991-92 for above mentioned two schemes is Rs. 9.8 lakhs. Under Special Central Assistance Scheme, 50 per cent subsidy is also provided for construction of fish ponds by tribal people in the area. The total outlay during 1991-92 for the above mentioned Special Central Assisted Scheme is Rs. 1.2 lakhs for construction of ponds by the tribal people and Rs. 80,000 for miner works in the area.

Exploitation of Construction Labour

Kali Bari and J-Block, Mandir Marg, New Delhi have been let out;

- (c) if so, what is the number and details of the quarters found fully let out; and
- (d) whether any action has been taken against the guilty allottees on the basis of this enquiry; if so, the details thereof and if not, what are the reasons therefore?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOP-MENT (SHRI M. ARUNACHALAM): (a) During the last two years, complaints about subletting of 24 quarters in 'H' Block Kali Bari and 'J' Block Mandir Marg, New Delhi were received.

- (c) and (d) Surprise inspections were carried out in 19 out of these 24 quarters. After detailed enquiries, subletting was found proved in 10 cases. Consequently allotment of these government residence were ordered to be cancelled and further penalties were imposed as provided under the Allotment Rules.
