- (b) if not, what are reasons for the delay; and
- (c) by when it will be commissioned?

THE MINISTER OF STATE (IN-DEPENDENT CHARGE) OF THE MINISTRY OF POWER AND NON-CONVENTIONAL ENERGY SOUR-CES (SHRI KALP NATH RAI): (a) to (c) According to DESU, the 66 KV Grid Sub-station at Mayur Vihar Phase-I has been commissioned in March 1991. The Sub-station has a firm capacity of 20 MVA. The new Sub-station has been commissioned to avoid the problems faced by the residents of the area. The cluster of Group Housing Societies in the area are getting the benefit of this Sub-station.

Power shortage in North-East Region

- 28. SHRIMATI BIJOYA CHAKRA-VARTY: Will the Minister of POWER AND NON-CONVENTIONAL ENERGY SOURCES be pleased to state:
- (a) whether Government are aware of the acute power shortage in the entire North-East Region;
- (b) whether it is a fact that the Thermal Power Station in Assam has not been functioning well; and
- (c) whether Government propose to tap major power source by implementing Sobansiri Dam Project on river Brahmaputra in Assam?

THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF POWER AND NON-CONVENTIONAL ENERGY SOURCES (SHRI KALP NATH RAI): (a) During the period April-June, 1991, the energy shortage in North-East Region was 6.7 per cent as against the All India Average shortage of 8.8 per cent.

- (i) The PLF of thermal power station in Assam during April-June, 1991 was 29.6 per cent as against the target of 31.9 per cent.
- (c) The Subansiri Dam Project proposal is at a preliminary stage. Certain environmental and rehabilitation aspects are being further investigated. The Government of India has also taken up the matter with the Arunachal Pradesh, where most of the submergence would take place. After the outstanding issues are sorted out, the project can be taken up, depending upon the availability of funds.

Decline in the production of coal

- 29. SHRI KRISHAN LAL SHAR-MA: Will the Minister of COAL be pleased to state:
- (a) whether it is a fact that coal production in the country has declined during the year 1990-91;
- (b) if so, what was its production during the year 1990-91 and reasons for the shortfall;
- (c) whether it is also a fact that there is deterioration in the coal distribution system in the country;
- (d) if so, whether Government have enquired into the affairs of Coal India Limited; and
- (e) if so, the outcome of the enquiry and the action taken thereon?

THE DEPUTY MINISTER IN THL MINISTRY OF COAL (SHRI S. B. NYAMAGOUDAR): (a) and (b) The coal production in the country during 1990-91 was 211.73 million tonnes. It was 10.84 million tonnes higher than the coal production in previous year.

- (c) No Sir, The coal despatches to various sectors during 1990-91 increased by 8.46 million tonnes over the previous year.
 - (d) and (e) Do not airse.
