THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI MADHAV RAO SCINDIA): (a) to (c) The National Committee on Tourism had recommended the merger of Hotel Corporation of India with India Tourism Development Corporation. The Department of Tourism has dropped the proposal after examination.

Gas linkage for Gandhar and Pipavav Gas-based power projects

- 34. SHRI VITHALBHAI M. PATEL: Will the Minister of PET-ROLEUM AND NATURAL GAS he pleased to state:
- (a) whether it is a fact that the proposal of the Gujarat Government for gas linkage for its Gandhar and Pipavav gas-based power projects are pending with the central Government;
- (b) whether it is also a fact that the previous Government had taken any decision to clear gas linkage for the Gandhar power project; and
- (c) if so, by when the Central Government would take a final decision for providing gas linkage to Gandhar and Pipavav power projects of Gujarat?

THE MINISTER OF PETROLEUM AND NATURAL GAS (SHRI B. SHANKARANAND): (a) to (c) The availability of gas for Gujarat Government's Gandhar Power Project is being reviewed.

A decision had been taken in principle to allocate gas for the Pipavav power plant. However, this is dependent on the economic feasibility of developing the Tapti off shore fields of ONGC.
