Agency (ATRA) to deal with sick mills in other areas. Government are yet to take a final decision on the recommendations.

Sanskrit University at Sringeri

*50. SHRI KAPIL VERMA: SHRIMATI SUSHILA TIRIA:

Will the Minister of HUMAN RE-SOURCE DEVELOPMENT be pleased to state:

(a) whether Government propose to set up a Sanskrit University named after Rajiv Gandhi at Sringeri; and

(b) if so, what are the salient features of the plan and by when it will be setup?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI AR-JUN SINGH): (a) and (b) A decision has been taken in principle to set up a Sanskrif University at Sringeri, Institutional structures will be initiated which would eviolve into a university over a period of time.

. New Typhoid germs

*51. CHOWDHRY HARI SINGH: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether Government's attention has been drawn to press reports in which it has been stated that some new typhoid germs have been found and patients suffering from typhoid caused by these germs are not curable by conventional antibiotics;

(b) if so, whether Government propose to set up a board of doctors and physicians to undertake research on a workable medicine for this type of typhoid; and

(c) if so, what are the details in this regard?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI M. L. FOTEDAR): (a) Yes, Sir.

(b) and (c) Medical experts of the country have found that Solmonella Typhi Phage Type E-II is a strain of Typhoid germ which is resistant to conventional namely, antibiotics, Chloramphenicol. However, this strain is sensitive to Norfloxacin and Cipro-floxacin. The said strain has not been found recently; it is known to the medical community and is duly covered in the educational courses of the medical colleges. Thus, there is no need to set up a board of dectors and physicians to undertake research in the matter. The National Institute of Cholera and Entaric Diseases, Calcutta, has, however, carried out studies on the prevalence of multi-drug resistant enteric fever in hospitals and efficacy of furazalidone against it, which are relevant and would help us to tackle the problem more effectively.
