- (d) if so, on what basis;
- (e) whether it is also a fact that the liabilities have been further revised; and
- (f) if so, what is the latest liability worked out and on what basis and when was it communicated to M|s. Glaxo?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI CHINTA MOHAN): (a) to (f) The original calculation of Rs. 37 crores made by the Department was based on the revised prices of the bulk drugs (Betamethasone and its salts) notified by the Government in January, 1989 on the recommendation of the Prince Review Committee. On further review, however, the tentative liability of the company, for the period upto 25-8-87, both for bulk drugs and formulations has gone up to Rs. 71.78 crores. The company has filed a Writ Petition in the Delhi High Court and ths matter is, therefore, sub-judice. The case has being contested by the Government.

Prices of Decontrol Medicines

increase in the price of decontrolled medicines after the announcement of DPCO, 1987.
