Development of Pigeonpea Lybrid

(b) Front-line demonstrations have been organised and seeds of parental lines have been made available by ICRISAT to

some State Agricultural Universities and seed companies for seed production. A programme for seed production has been undertaken by the National Seeds Corporation, the State Farms Corporation of India and Seed company.

importance and criti-Considering the cality of the problems of urban transport faced by the State Governments the Government of India have played a catalytic role and have financed the suburban and metro rail systems in the four metropolitan cities of Calcutta. Bombay, Madras and Delhi. In Calcutta, 97 kms of metro rail has already been commissioned in addition to the circular rail commissioned in June 1990. Work is in progress in respect of expansion of lines between Andheri and Bandra and extension of rail line from Mankurd to Belapur in New Bombay. Work is also in progress on the Mass

Rapid Transit System between Beach and Luz in Madras. In so far as Delhi is concerned, a Techno-Economic Feasibility Report for a metropolitan model mass rapid transit system has been prepared by M/s RITES

Apart from this, the State Governments have prepared or have taken up the work of preparing Techno-Economic Feasibility Report for the introduction of Mass Rapid Transit Systems in Madras (inner circular corridor), Bombay (strengthening of the multi-model urban transport network) and Calcutta (extension of Metro line to Garia), and for introduction of Light Rail Transport System in Hyderabad. Studies have also been taken up by the respective State Governments for improving the existing transportation systems in the cities of Ahmedabad, Jaipur and Bangalore.

During the year 1990-91, a sum of Rs. 100 crores was spent on the construction of Calcutta Metro and a sum of Rs. 10 crores for the construction of Madras Mass Rapid Transit Project.

The expenditure incurred on Operation and Maintenance of the completed portion of the Calcutta Metro System during the same year (1990-91) was Rs. 8.74 crores.
