Closure of News-Papers

*109. SHRIMATI VEENA VERMA: SHRI KAPIL VERMA:

- (a) whether Government are aware that a number of newspapers, including the Amrita Bazar Patrika group (Calcutta), the Indian Express (Hyderabad) and the Times of India (Lucknow) are lying closed; and
- (b) if so, what steps are being taken to reopen them?

THE MINISTER OF STATE OF THE MINISTRY OF LABOUR (INDEPENDENT CHARGE) (SHRI K. RAMAMURTHY): (a) and (b) A Statement is laid on the Table of the House.

Statement

Closure of several newspapers and steps taken to reopen them

The appropriate Government under the Industrial Disputes Act, 1947 for newspaper establishments is the State Government.

- 2. According to the information received from the Government of West Bengal, the Amrita Bazar Patrika Group stopped publication with effect from February 6, 1991 owing to acute financial stringency, and not on account of any industrial relations problem.
- 3. The Government of Andhra Pradesh have informed that the workers of Indian Express in Andhra Pradesh struck work with effect from 25.4.1991 on the question of implementation of the Bachawat Award. The management resorted to lock out of their units at Hyderabad Vizianagaram from 18.5.1991. Efforts at conciliation having failed, the State Government on 4.7.1991 referred to dispute for adjudication and prohibited continuance of the strike and lock out. The neurspaper has since resumed publication.

4. The Government of Uttar Pradesh have informed that following a strike by the workmen of the Times of India, Lucknow, with effect from March 20, 1991 on a demand for 20 per cent bonus, the management declared lock out of the establishment on May 7, 1991. The State Government have referred the dispute relating to the question of bonus for adjudication and are continuing their efforts at conciliation of an industrial dispute arising out of disciplinary action taken against some workers by the management.
