## Modernisation programmes in the field of telecommunications

608. SHRI M. A. BABY: Will the Minister of COMMUNICATIONS be pleased to state:

- (a) the modernisation programmes being planned in the country and in Kerala in the field of telecommunications in the future and the details thereof; and
- (b, whether this would result either in the deduction of jobs in the sector or stagnation in job appointments?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS

(SHRI P. V. RANGAYYA NAIDU): (a) Modernisation of telecom. services in the country proposed in the draft 8th Plan document include:—

- Automatisation of manual exchanges.
- Replacement of life expired/worn out equipment.
- Provision of additional ducts for underground cables.
- Induction of modern equipment such as digital electronic equipment (both in local and long distance

network), Fibre Optic and digital microwave.

- Extensive computerisation of Telecom, services.
- Use of improved computerised network management techniques.
- The 8th Plan proposals envisage:
  - (i) replacement of 14 takh lines (inclusive of 3.48 takh lines of manual exchanges) in the country including around 76,000 lines in Kerala (Kerala exchanges have been fully automatised by 31-3-90).
  - (ii) provision of 2000 Kms. of ducting for the country out of which 60 Kms, are proposed in Kerala.
  - (iii) around 94 per cent of the proposed addition of local switching equipment by digital electronic equipment, all over the country including Kerala.
  - (iv) 21750 Rkms of fibre optic systems out of which 1170 Rkms in Kerala.
  - (v) 3 SBT systems at Cochin, Trivandrum and Kozhikode to modernise telegraph services.
