

**Adhoc priet increase in Drugs and finished medicines**

670. SHRIMATI RATAN KUMARI: Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that Government have decided to allow 20 per cent adhoc increase in the prices of Drugs and finished medicines;

(b) if so, the details thereof;

(c) whether it is also a fact that Companies have increased the prices of price decontrolled medicines without any justification-

(d) whether it is a fact that bis Ministry are monitoring the prices of non-scheduled finished Medicines;

(e) if so what are the names of non-scheduled medicines whose prices have been increased under DPCO, 1987; and

(f) what was the price of each before DPCO, 1987 and what is the present price and what percentage of increase in each case?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI CHINTA MOHAN): (a) and (b) No, Sir.

(c) There has been some increase in the prices of decontrolled medicines which is inevitable in a situation of rising prices.

(d) Yes, Sir.

(e) and (f) Such formulations and their dosages being thousands in number, the time and labour involved will not be commensurate with the results likely to be acheieved.

**Sale price of Alpha interferon Injection**

(d) whether it is a fact that according to DPCO 1987 the importer has to provide certain details before marketing of the product;

(e) if so, what is the name of importer and what price has been printed on the container as per the provisions of DPCO 1987;

(f) whether it is also a fact that importer has appointed a sole selling agent in India; and

(g) if so the name of the agent and what are the details of selling arrangements and how much commission is paid?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI CHINTA MOHAN): (a) to (g) M/s. Genetics Sciences (India) Pvt.

Ltd. had imported 3000 vials of Alpha Interferon Inj. from M/s. National Geno Sciences Inc., U. S. A. @ \$ 34 per vial as its C. I. F. cost. The entire stocks had been destroyed on 7th May, 1991, under instructions from foreign supplier in the presence of Drug Inspector Bangalore Distt., And hence no sales were effected.

(c) and (d) Yes Sir.
