Vulnerability of East Coast of Tamil Nadu

- 679. SHRI S. K. T. RAMACHAND-RAN: Will the Minister of DEFENCE be pleased to state.
- (a) whether the Government are aware of the fact that the East Coast of Tamil Nadu has become vulnerable to Defence of India due to: (i) its iong coast, (ii) innumerable fishing boats going into the Sea, (iii) fishermen conniving with the smugglers and terrorists to smuggle weapons and petroleum products out of India, (iv) the sophisticated weapons and Vessels used by the terrorists from neighbouring Island country, and (v) the inadequate and luke warm steps taken by the erstwhile D.M.K. Government arrest the inflow of terrorists though its Coasts;
- (b) if so, what steps Government have taken to protect and defend the country;
- (c) what vigilance steps are in force to arrest and contain the daily insurgency of terrorists through this vulnerable coast into Tamil Nadu; and
- (d) whether Government propose deploy a heavy column of Coastal guards with sophisticated weapons and boats to put an end to the inflow of terrorists and their allied activities?

THE MINISTER OF DEFENCE (SHR! SHARAD PAWAR): (a) to (d) The Government are maintaining a close watch over all developments which have a bearing on national security for taking officetive measures to safeguard national security interests at all times. Due attention also been given by the Govt, to the requirements of the Tamil Nadu Coast.

The Indian Navy and Coast Guard are maintaining intensive surveillance/patrolling in the Palk Bay/Palk Straits. For this purpose, their resources have been mented and 2 Naval Detachments, each at Rameshwaram and Nagapattinam, have been set up. A special drive recently launched by the Tamil Nadu Government has resulted in the seizure of sizeable quantities of arms, ammunition etc. and arrest of a number of militants.

Defence spending

- (a) whether Government propose to reduce the present level of defence spending:

THE MINISTER OF DEFENCE (SHRI SHARAD PAWAR): (a) to (d) As reflected in the General Budget 1991-92, there is a provision of Rs. 16,350 crores for Defence Services as against an allocation of Rs. 15,750 crores in Reivsed Estimates 1990-91.

Government takes into account all relevant considerations, including effective defence preparedness, while deciding on the allocations for the various sectors.
