- (i) Expansion of Vijaipur plant of National Fertilizers Ltd.
- (ii) Expansion of Aonla plant of IFCO.
- (iii) Expansion of Hazira plant of KRIBHCO by setting up a intro-phosphate unit.
- (iv) Revamping/expansion of the plant of Madras Fertilizers Ltd.
- (v) Expansion of Thai alant of Rashtriya Chemicals and Fertilizers Ltd. by setting up ammonia/nitro-phosphate plant.
- (vi) Modernisation and expansion of Cochin-II plant of FACT.
- (vii) Putting up of a modern 900 TPD Ammonia plant in deplace-ment of three old Ammonia Plants at Udyogmandal by FACT.
- (viii) Upgradation of the Gorakhpur Plant of Fertilizer Corporation of India.
- (ix) Phase-I Rehabilitation, including a captive power plant of 40 MW, of Ramagundam plant of Fertilizer Corporation of India.
- (x) Phase-I Rehabilitation of Talcher plant of Fertilizer Corporation of India,
- (xi) Modernisation of Sindri plant and setting up of a new captive power plant at Sindri by Fertilizer Corporation of India.

## Fertilisers requirement

658. SHRI R. T. GOPALAN; Will the PRIME MINISTER be pleased to state:

(a) whether Government have been able to meet the fertilisers requirement of various States during 1988-89, 1989-90 and 1990-91;

- (b) if not, the demand and actual supply of fertilisers to Tamil Nadu during the aforesaid period, yearwise; and
- (c) whether the supply is sufficient to meet the demand of the State?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FER-TILISERS (SHRI CHINTA MOHAN); (a) to (c) Yes Sir. Government, on the whole, was able to meet the fertiliser requirements in the country during 1988-89, 1989-90 and 1990-91. There were, however, instances in the past when in certain pockets shortage was experienced temporarily due to constraints in respect of movement of material and shortfall in production. Remedial measures were taken immediately to improve the supply so as to meet the requirements.
