panchayat, of the country from the year 1989-90.

- (b) The implication of bringing every village panchayat under the JRY is to ensure that a part of the supplemental employment and income for the needy people is generated within rhe panchayat area itself. Besides, each panohayat is able to get funds to create assets of socio-economic relevance. The decision as to what programmes should be implemented with the JRY funds lies with rhe village panchayat itself, under the overall control of the village assembly. The village panchayat is, therefore, able to implement socioeconomic programmes of their high priority.
- (c) Tiie outlay for the year 1991-92 has been kept at Rs. 2623. 13 crores. The prescribed ceiling of administrative expenses is 2 per cent of the total allocation.
