## Fire at Sena Bbavan

# \*174. DR. RATNAKAR PANDEY; SHRI SUNIL BASU RAY;

Will the Minister of DEFENCE be pleased to state:

(a) whether it is a fact that recently there was a major fire at Sena Bbavan at New Delhi which burnt out many classified records; if so, the details thereof;

(b) whether Government have made any enquiry regarding the matter; and

(c) if so, the findings thereof and what steps Government propose to take to prevent such major fires at such sensitive places like the Sena Bhavan?

THE MINISTER OF DEFENCE (SHRI SHARAD PAWER); (a) There was a fire in Sena Bhavan on 28 lune, 1991 which was localised in a small area. No classified records were burnt out.

(b) and (c) A Court of Inquiry has been set up to investigate the cause of fire, to determine the extent of damage and to recommend remedial steps to prevent incidences of fire. However, work is already in progress *to* execute improved fire detection, prevention and fire fighting measures in Sena Bhavan.

## Manufacturing of Jaguar Aircraft

◆175. SHRI SHIV PRATAP MISHRA: the Minister of DEFENCE be pleased to state;

(a) whether Government have resumed the manufacturing of Jaguar aircraft; and

(b) if so, what are the reasons therefor?

THE MINISTER OF DEFENCE (SHRI SHARAD PAWER): (a) Jaguar production is an ongoing programme in HAL
