have been sanctioned to all those whose names were recommended by Members of Parliament (Lok Sabha) during January to March 91; and

(b) if not, what steps are being taken in the matter so that the recommendations given by M.P. may be fulfilled?

THE MINISTER OF PETROLEUM AND NATURAL GAS (SHRI B. SHANKARANAND): (a) No, Sir.

(b) The pending cases are being looked into.

### Representation of employees of Indian Airlines

1028. SHRI GURUDAS DAS GUPTA: Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:

- (a) whether Indian Airlines authorities have received any representation on 3rd June, 1991 signed by more than 100 employees;
  - (b) if so, the details thereof; and
- (c) if so, Government's reaction thereto?

THE MINISTER OF CIVIL AVIA-TION AND TOURISM (SHRI MADHAVRAO SCINDIA); (a) Yes, Sir.

- (b) The Administrative offices of Indian Airlines were declared close on 20-5-91, 22-5-91 and 24-5-91 on account of Lok Sabha Elections, the demise of Shri Rajiv Gandhi and his funeral respectively. However, the Receivation Office of Indian Airlines which is essential for the operations of air services was not closed on these days. The employees of the Reservation Office have demanded that they should be given 'days off' in lieu and a similar practice should be followed in future.
- (c) It is not possible to acced to the demand of the employees in this matter?

#### Royalty on coal to Assam

1031. DR. NAGEN SAIKIA: Will the Minister of COAL be pleased to state:

(a) whether the distributing point of coal from Assam has been located in West Bengal;

- (b) what amount of revenue is generally earned from Assam coal by the West Bengal Government; and
  - (c) whether Government of Assam also gets revenue from it?

THE DEPUTY MINISTER IN THE MINISTRY OF COAL (SHRI S. B. NYAMAGOUDA): (a) and (b) Assam coal despatched by rail to steel plants is transhipped from metre gauge wagons to broad gauge wagons at Kamakhyaguri which is located in West Bengal. The Govt. of West Bengal does not get any revenue from this transhipment.

(c) Govt. of Assam is presently levying Assam Land Tax at the rate of Rs. one hundred per tonne of coal. It also levies Sales Tax on sale of coal within the State. In addition the State Govt. collects royalty on coal, the existing rate being Rs. six and paise fifty only per tonne of coal despatched.

## Continuing of Gulf Surcharge

1032. SHRI DINESHBHAI TRI-VEDI: Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:

- (a) whether it is a fact that Gulf surcharge was introduced by Government for meeting the cost of bringing the Indian citizens back home during the recent gulf war;
  - (b) if so, how long will this stay;
- (c) whether the passengers brought back from gulf are required to pay their fare amount; and
  - (d) if so, the details thereof?

THE MINISTER OF CIVIL AVIA-TION AND TOURISM (SHRI MADHA RAO SCINDIA): (a) In the wake of an all round increase in costs following the Gulf crisis, it became necessary to impose the Gulf surcharge.

- (b) Discontinuance of the surcharge is not under consideration now.
- (c) No fare was charged by Air India and Indian Airlines for evacua-

tion of the Indian nationals from the Gulf region.

(d) Does not arise.

#### Production of LPG cylinders

1033. SHRI SAMAR MUKHERJEE: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether any proposal was received from Haldia procision Engineering Private Limited, Calcutta for commercial production of LPG cylinders;
- (b) whether it is also a fact that the above company had successfully carried out the trial fabrication to the minute specifications of the Bureau of Indian Standards and Controller of Explosives;
- (c) if so, whether Government have given clearance for commercial production of LPG cylinders to the above company and advised the Indian Oil Corporation to place orders with the company; and
- (d) if not, what are the reasons therefor?

THE MINISTER OF PETROLEUM AND NATURAL GAS (SHRI B. SHANKARANAND): (a) Yes, Sir.

- (b) Yes, Sir, according to IOC.
- (c) and (d) No advice has been given by the Government to the IOC in this regard. IOC places orders for new LPG cylinders as per policy.
