Woollen Carpet export units

- 1311. SHRI SHANTI TYAGI: Will the Minister of TEXTILES be pleased to state:
- (a) whether it is a fact that due to the withdrawal of Cash Compensatory Support from the 1st July, about 10,000 hand knotted woollen carpet export units are facing closure;
- (b) if so, whether Government would reconsiderr the continuance of Cash Compensatory Support to this carpet trade; and
- (c) if not, what steps Government propose to adopt to help the exporting units in this industry

THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF TEXTILES (SHRI ASHOK GEHLOT): (a) No Sir.

(b) and (c) Government is not considering such a proposal at present. However, it is expected that the recent exchange rate adjustment visavis the rupee and the enhanced replenishment Licenses will have an overall positive impact on carpet exports.
