(b) and (c) Forty fixed deposit receipts (FDRS) aggregating Rs. 1.02 crores (including interest) were released in the Sadar Zazar, Qutab Road branch of Punjab and Sind Bank on 15-5-91 by the branch manager inspite of advice of the Central Economic Intelligence Bureau (CEIB) not to make payments since they were suspected to be in bogus names. The amount was withdrawn on 16-5-91 > from the Savings Bank Accounts, opened on 15-5-91, to which these amounts were credited the same day by way of manager's cheques. The matter has been taken up by the Central Bureau of Investigation.

THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): (a) Delhi Administration have informed that 21 industrial units which could be termed as hazardous on the basis of quantity of chemicals manufactured, handled and stored by them have been identified in Delhi.

(b) Hazardous units have to comply with the rules made under the . provisions of Factories Act, 1948 and also under the provisions of Manufacture, Storage and Import of Hazardous Chemicals Rules, 1989 framed under the Environment (Protection) Act,1986. Some of these rules relate to the preparation of on-site and off-site plans, safety in transportation, disposal of wastes and effluents, precaution in case of fire, safety of health of workers, proper information'

regarding hazardous processes and hazardous operations etc. Action is taken against units violating such rules under the relevant provisions of the Acts.
