- 4. Integrated Child Development services Scheme (ICDS).
  - 5. Special Nutrition Programme (SNP).
  - 6. Balwadi Nutrition Programme (BNP).
  - 7. Mid-day Meal Programme.

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI RAMESHWAR THAKUR): (a) Government has been floating schemes to attract NRI " remittance from time to time. New schemes have also been proposed as part of the budget proposals for 1991-92.

(b) FCNR deposits did not carry an interest rate of 13.95 per cent per

annum four years ago. The interest rates on FCNR Deposits are regularly reviewed in the light of prevailing interest rates in overseas markets so that they are not at significant variance with the interest rates abroad, yet are attractive enough for NRIs to invest in India.
