Extract of promotion rules

A student who is not eligible to be declared "passed" or 'promoted' can be declared eligible for appearing ar the "Compartmental Examination" provided he (she fails only in one or two subject, provided he/she gets minimum of 15 per cent marks in those subjects. If a candidate gets 40 per cent or more in the aggregate of the passing subjects and gets less than 15 per cent in not more than two other subjects he|she is eligible for compartment at a subsequent examination in these subjects to be held in the month of May before the summer vacation and to be known as Compartmental Examination". If the student secures in the subjects, in which he/she has taken the Compartmental examination, atleast 33 per cent marks (disregarding the terminal tests marks), he|she shall be declared "Promoted" Compartmental in the Examination and promoted to the next higher class. No grace marks will be awarded to a student taking the Compartmental Examination.
