# क्षेत्रीय भाषास्रों को कम्प्यूटरीकृत किया

1291. श्री मोहम्मद श्रफजल उर्फ मीम ग्रफजल: क्या मानव संसाधन विकास संबी यह बताने की छपा करेंगे कि देश में सभी क्षतीय भाषात्रीं को कम्प्यटरोक्टत करने के संबंध में सरकार द्वारा क्या कदम उठाये गये हैं ग्रीर गत वर्ष के दौरान प्रत्येक भाषा पर कितनी धनराशि खर्च की गई ?

मानव संसाधन विकास मंत्री (श्रीः श्रर्जुन सिंह) : इलैक्ट्रांनिका विभाग ने वैयक्तिक संगणक में कार्ड जोड़ने के लिए रेखा चित्रों पर ग्राधारित निपूण निषि प्रौद्योगिको के विकास को प्रायाजित किया है जो अनेक भारतीय तथां अन्तर राष्ट्रीय भाषात्रीं के संगणीकरण को सुकर बनाता है। इसके अलावा इलैक्टानिको विमाग ने भारतीय भाषात्रों के प्रौद्योगिको विकास के लिए एक कार्यक्रम की शुरुग्रात की है।

इन प्रयोगों में क्योंकि एक समेकित दिष्टिकोण शामिल है, अतः वैयक्तिक भाषा पर खर्च की गयी राशि के ब्यौरे उपलब्ध नहीं हैं। पिछन वर्ष रेखा चित्रों पर श्राधारित निपुण लिपि प्रौद्योगिकी पर खर्च की गयी कुल राशि तत्काल उप-लब्ध नहीं है परन्तू ग्रगस्त, 1988 से मार्च, 1991 तक 80.00 लाख रुपये को राशि खर्च की गयी थी।

## Norms for recognition of institutionsDelhi conducting courses like D.Pharma

1292. SHRI M. A. BABY: Will the HUMAN Minister of RESOURCE DEVELOPMENT be pleased to state:

- (a) what are the norms/rules laid down by the Board of Technical Edu cation. Delhi Administration for affi liation (recognition of institutions con ducting D. Pharma, Diploma in Medi Laboratory Technology and Certificate Course in X-ray under the community scheme of Government;
- (b) whether Board of Technical Education has prescribed Syllabus,

books and other necessities for the above courses; and

(c) if so, what are the details in this regard, course-wise?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (c) There is no scheme as "Community Scheme"

under the Government. However, there is a scheme of "Community Polytechnics" under the Central Government. No such courses are being conducted under this scheme in Delhi.

However, the Board of Terminal Education. Delhi Administration has prescribed affiliation rules for the Diplomaa Courses in Pharmacy and Medical Laboratory Technology which are being conducted in the Polytechnics in Delhi. These rules interalia include examination of Management System, availability of Primary infrastructural facilities and financial status of the society/institution and need for starting of such a programme. The Board has also prescribed syllabus for these two courses but no books has been prescribed. No Certificate Course for X-Ray is being conducted by this Board.

## Allotment of land for construction of AGs office in Assam

1293. SHRIMATI BIJOYA CHAK-RAVARTY: Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that the Government of Assam had allotted a big plot of land for the construction of A.G.'s office building and quarters for A.G.'s staff more than ten years back;
- (b) if so, what are the reasons for which construction of building has not been completed till now; and
- (c) whether there is any possibility that the A.G.'s office in Assam will be shifted from the rented building to its own building?

THE MINISTER OF STATE IN THE (SHIRI MINIST of OF FINANCE SHANTARAM POTDUKHE: (,a) to (c) Land measuring 17 bighas, 3 Kattas and 8 Lacha for construction of ottice building for the office of the then A.G., Assam, was allotted by the Assam Government m 1982. As the proposed plot of land was not easily connected with the main, road, the Government of Assam was approached to acquire additional land which was done in May, 1980 and the approach road was constructed. in September, 1987, plots measuring 43 Bighas were also selected for the construction of staff and IA & AS officers quarters. The cost for latter plots of land was finally settled by the Assam Government only in August 1990. The structural designs for the office complex are presently being prepared by the CPWD. The layout plan of the construction of staff quarters has also been approved in March 1991. It is, therefore, difficult to state at this stage when the offices would be shifted to the new building.

### Shifting of A.G.'S Office in Assam

- (a) whether it is a fact that the top officials of the Accountant Generals Office function both in Assam and Meghalaya as the shifting of Accountant General Office has not been completed till today;
- (b) if so what are the reasons therefor; and
- (c) by when such shifting will be completed?

THE MINISTER OF STATE IN THE FINANCE MINISTRY OF (SHRI SHANTARAM POTDUKHE): (a) to (c) The two major offices under the Comptroller & Auditor General of India who are doing the work relating to Accounts Entitlement and Audit for the States of

Assam, Meghalaya Arunachal Pradesh and Mizoram are Accountant General (Accounts & Entitlement) Assam and Principal Accountant General (Audit) Assam, Meghalaya, Arunachal Pradesh & Mizoram. The former has his offices both in Guwahati and Shillong. Similarly, the latter has offices at Shillong and Guwahati for doing the necessary Audit work.

The construction of the office building for the offices of the Accountant General (Accounts & Entitlement) and Principal Accountant General (Audit) for which approval has been given in March 1990 will ba taken up by Central Public Works Department after finalisation of drawings and tenders. It is, therefore difficult to state at this stage as to when the offices will be actually shifted
