THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) After Nationa! Policy on Education (NPE) was adopted by the Parliament in

May, 1986, several steps were taken for its implementation in furtherance of its objectives. A number of new schemes were launched in key areas like Elementary Education including Operation Blackboard, Non-Formal Education, restructuring of Teacher Education, establishment of Navodava Vidvalavas, Vocationalisation Education, Science Education, Education Technology and Modernisation in the Higher and Technical Education sectors including removal of obsolescence. The Government have decided to resume the implementation of NPE with renewed vigour.

(c) and (d) The Government do not propose to make any fundamental change in the policy. However it has been decided to constitute a Committee of the Central Advisory Board of Education to review the implementation of NPE taking into account the recommendations of the Committee for review of the National Policy on Education as well as the various developments that have taken place since NPF
