## Introduction of Units Projects and Assignment in Class IX and XII In Central Schools

1281. SHRI S. K. T. RAMACHAN DRAN: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether it is a fact that units, projects and assignments have been introduced in Classes IX and XI of the Kendriya Vidyalayas from the last academic sessions thus resulting in the wastage of lot of time of students involved in these activities; and
- (b) if so, the reasons therefor and the steps taken to re-introduce the earlier practice in this regard?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) The promotion of students to the next higher class in Kendriya Vidyalayas is based on continuous evaluation of their performance throughout the year taking unit tests, projects and assignments as integral parts of this process of evaluation. There has been no recent change in this system.

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND

FAMILY WELFARE (SMT. D. K. THARA DEVI SIDDHARTHA): (a) to (e) The National objective is to achieve a balanced growth of population by 2000 AD. The latest Census results have shown that the present growth rate of our population is still over 2 per cent per annum and the Government is seriously concerned about it. In order to curb the high population growth, it is considered imperative to undertake new initiatives. In this context, all aspects of implementation of the. Family Welfare Programme are being looked into. This involves gearing up of the entire implementation machinery in close consultation with State/UT Governments. greater emphasis on Maternal and Child Health care Programmes, launching of innovative Information, Education and Communication efforts, improvement in the quality of services, better arrangements for supply and distribution of contraceptives at the doorsteps of acceptors, increased coverage of younger couples with high fertility potential under spacing methods of contraception, mstitutionalisation of mechanisms for inter-sectoral coordination. initiatives to seek involvement of nongovernmental organisations in supplementing and complementing Government efforts in the delivery of Family Welfare services and generation of demand for these services.
