Inquiry into firing incident near Sarojini Nagar, New Delhi

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF HOME AFFA-IRS (SHRI M. M. JACOB): (a) and (b) No magisterial enquiry into the police firing near Sarojini Nagar, New Delhi on 25th September, 1990 has been conducted.

(c) and (d) Following a complaint from Shri R. N. Sharma, regarding the death of his son, Shri Aditya Narain, in the police firing, the Commissioner of Police ordered the complaint to be enquired into by Additional Deputy Commissioner of Police (South-West District.)

The welhi police have reported that the circumstances on the morning of 25th September, 1990 as brought out by the enquiry are as follows:-

There were several incidents of violence, arson stoning and forgible closure of

markets in the Sarojini Nagar area. A Sub-Inspector and a Constable confronted by a violent mob near Sarojini Nagar. Finding themselves mobbed by the riotous assembly and after attempts at persuasion failed, a shot was fired in the air and thereafter the Sub-Inspector resorted to firing from his revolver. Shri Aditya Narain Sharma was injured in the firing and subsequently died on 14th October, 1990. Sub-Inspector was transferred.

Non-working elephone of a Member of **Parliament**

1376. SHRI NYYODEK YONGGAM: of COMMUNICA-Will the Minister TIONS be pleased to state:

- (a) whether it is a fact that the telephone No. 320 Pasighat, Arunachal Pradesh meant for one of the Members of Parliament of Arunachal Pradesh is not working since February, 1991; and
- (b) if so, what is the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI P. V. RANGAYYA NAIDU): (a) No, Sir. However, telephone went out of order frequently and remained interrupted for quite some time during March, 1991 to June, 1991.

(b) The Telephone is provided on overhead lines of considerable length (23 Km) and passing through jungles which makes it vulnerable for breakdown. Patrolling of line, sectionalizing and restoration takes some time due to difficult terrain.

Withdrawal of buses on route Number 920 and 973

THE MINISTER OF STATE (INDE-PENDENT CHARGE) OF THE MIN-ISTRY OF SURFACE TRANSPORT (SHRI JAGDISH TYTLER): (a) to (c) Route No. 920 is being operated by private buses under DTC between Palika Kendra and Keshav Puram. Route No. 973 which runs between Palika Kendra and Keshav Puram is served by DTC buses. Two trips on Route No. 973 operate from the Central Secretariat at 1745 and 1810 hrs .for Keshav Puram. No trip on Route No. 920 starts from Kendriya Terminal. It is a fact that three private buses operating on Route No. 920 have been withdrawn by the owners. The contract for two of the private buses were terminated as the vehicles have crossed the age limit as per the agreement by DTC with the private bus owners. The third bus was withdrawn by the private operator on his own. At present this route is served by two private

(d) to (f) The buses plying on Route No. 920 and 973 are running with full load. There is no scope for further augmentation of buses on these routes because or fleet constraints.
