offices on time for want of DTC buses not plying during peak hours in sufficient numbers;

- (b) if so, what action would Government take to provide sufficient number of buses to these colonies to enable the people to reach their offices cm time; and
  - (c) if not, the reasons therefor?

THE MINISTER OF STATE (INDE-PENDENT CHARGE) OF THE MINISTRY OF SURFACE TRANSPORT (SHRI JAGDISH TYTLER): (a) to (c) DTC provides 21 regular services from Outer Delhi and 68 Limited Trips for the commuters from Outer Delhi to reach their offices. On account of Inancial constraints. DTC have not been able to add new buses to its fleet to augment its capacity. DTC have been able to procure buses only on replacement account. The Government have already recommended to the Delhi Administration to introduce a scheme of Special Stage Carriage Permits at a fare structure higher than that of DTC. The Delhi Administration have also been advised to grant additional Stage Carriage Permit to private operators.

## **New DTC Bases on various Roral Routes**

1466. SHRI SANTOSH KUMAR SAHU: Will the Minister of SURFACE TRANSPORT be pleased to state:

- (a) whether it is a fact that DTC bus services for the large number of pas sengers coming from distant villages daily to duties have been deteriorating for the last two years;
- (b) whether it is also a fact that more new buses are given to the depots covering urban areas of Delhi where private buses under DTC operation are serving the commuters whereas the DTC buses on rural routes of Delhi are old and break down ferquently on then- ways, if so, the reasons therefor and the number of new buses provided to the depots like Bawana, Dichau Kalan etc.; and
- (c) if so, what remedial steps Government propose to take to provide

more new buses on route number 131, 133, 109, 106, 136, 135, 176, 851, 854, 871 and 855?

THE MINISTER OF STATE (INDE-PENDENT CHARGE) OF THE MINISTRY OF SURFACE TRANSPORT (SHRI JAGDISH TYTLER): (a) Besides jproviding regular services, DTC has provided 148 Limited Stop trips from rural areas for the benefit of passengers coming from distant villages.

- (b) No, Sir. All the new buses are distributed to every region.
- (c) In view of answer to (b) above, does not arise.
