Want of sufficient irrigation facilities for paddy crops in Cauvery Belt Region of Karaikal

774. SHRI V. NARAYANASAMY; Will the Minister of WATER RESOURCES be pleased to state;

- (a) whether Government are aware of the fact that due to failure of monsoon for the last four years, the Cauvery belt region of Karaikal, a part of Pondicherry region, is suffering for want of sufficient irrigation facilities for paddy crops;
- (b) whether the Cauvery Water Tribunal set up by Government has passed any interim award for the benefit of riparian States like Tamil Nadu and Pondicherry; and
- (e) when the final award relating to Cauvery water dispute will be expected?

THE MINISTER OF WATER RESOURCES WITH ADDITIONAL CHARGE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI MANUBHAI KOTADIA): Apart form reliability of monsoon rains, the success of irrigation depends on condition of the distribution net-work, water distribution efficiency, location of irrigation areas in the comman and availability of back up storages.

- (c) Inter-State Water Disputes Act, 1956, does not prescribe any time limit for the Tribunal to give its award.
