(c) Three persons have been arrested and the following documents seized:—

- (v) 32 rubber stamps of various transport authorities.
- (vi) 50 photos.

(d) and (e) One of the accused is a suspended employee of Delhi Transport Authority. He has been arrested by the police.

**Inclusion of Manipuri in the Eighth Schedule to the Constitution of India**

(a) whether it is a fact that Manipuri language has been the official language of Manipur even before the Constitution of India came into force in 1950;

(b) whether there is any proposal under Government's consideration to include Manipur Language in the Eighth Schedule to the Constitution of India; if so the details thereof; and

(c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI SUBODH KANT SAHAY): (a) Yes, Sir.

(b) and (c) Yes, Sir. However, no decision has been taken to include any more languages in the Eighth Schedule to the Constitution of India.
