- (b) The culprits used to issue fake driving licences and registration books by affixing fake stamps.
- (c) Three persons have been arrested and the following documents seized:—
  - (i) 34 prepared fake driving licences.
  - (ii) 13 blank driving licence forms.
  - (iii) 17 fake registration books.
  - (iv) 50 blank registration certificate forms.
  - (v) 32 rubber stamps of various transport authorities
  - (vi) 50 photos.
- (d) and (e) One of the accused is a suspended employee of Delhi Transport Authority. He has been arrested by the police.

## Programme for women and child development during Eighth Plan

- (a) whether it is a fact that Manipuri language has been the official language of Manipur even before the Constitution of India came into force in 1950;
- (b) whether there is any proposal under Government's consideration to include Manipur Language in the Eighth Schedule to the Constitution of India; if so, the details thereof; and
  - (c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI SUBODH KANT SAHAY): (a) Yes, Sir.

(b) and (c) Yes, Sir. However, no decision has been taken to include any more languages in the Eighth Schedule to the Constitution of India.
