THE MINISTER OF HEALTH AND FAMILY WELFARE (PROF. SHAKE-ELUR REHMAN):

Statement

(a) to (f). As per the directive or the all the Supreme Court concerned State/UT Governments except Jammu & Kashmir and Andhra Pradesh contribute 15 per cent MBBS/ BDS seats, without taking into account any reservation, for All India Entrance Examination conducted by Central Board of Secondary Education (C.B.S.E.). New Delhi. The MBBS and BDS seats contributed by the concerned State/UT Governments other than private medical colleges, are 1412 and 117 respectively.

In may, 1990, the CBSE conducted All India Pre-medical/Pre-dental examination and sent a combined merit list of 1600 candidates and a waiting list of 1056 candidates for filling up of 1412 seats in MBBS Course and 117 in BDS The Director General course. Health Services New Delhi, allots seats/ colleges to the candidates in the merit So far, candidates whose first option was either MBBS or BDS have been allotted seats/colleges upto the rank of 1978. The remaining candidates will considered for allotment of seats shortly against the vacancies arising out of the non-joining of candidates allotted MBBS Course and against remaining BDS seats, subject to availability of seats and also subject to non-reversion of seats to the concerned State/UT Governments.

Syringe invented by US agency for International Aid

385. SHRI SYED SIBTEY RAZI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether Government are aware that U.S. Agency for International Aid has invented one special type of syringe which can be used once only;
- (b) whether such invention has been found useful to present epidemic diseases and other serious diseases like AIDS:
