THE MINISTER OF EXTERNAL AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) The ship M. V. 'Vishwa Siddhi' carried to Iraq, 9,475 tonne of foodstuff for this purpose.

(b) 2,315 tonnes comprising:

Rice-2,034 tonnes

Sugar-58 tonnes

Pulses—152 tonnes

Atta-43 tonnes

Chillies-9 tonnes

Coriander-6 tonnes

Salt, Tea, Pickles & Milk—13 tonnes was distributed to Indian nationals.

(c) The M. V. Vishwa Sinddhi' unloaded its cargo of foodstuffs and left Iraq on December 11, 1990. No other ship was sent to Iraq for this purpose.

(b) and (c) The Government of India have not so far rehabilitated the repatriated Indians from Gulf countries. The total expenditure on repatriation of Indian citizens from Iraq and Kuwait is approximately Rs. 300 crores.

Rehabilitation of people affected by Irrigation and river valley products

THE MINISTER OF WATER RE-SOURCES WITH ADDITIONAL CHARGE OF THE MINISTRY OF SUR-FACE TRANSPORT (SHRI MANU-BHAI KOTADIA): (a) and (b) The Government have formulated a draft National Policy on rehabilitation of project displaced persons belonging to Scheduled Tribes. This policy, when finalised, will also be applicable to Scheduled Tribe people affected by irrigation and river valley projects. It stipulates conditions for cultural and socio-economic rehabilitation, so as to cause least distress through displacement.
