THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND THE MINISTER OF STATE IN THE MINISTRY OF WELFARE (SHRI RAMJI LAL SUMAN); (a) and (b) Yes, Sir.

(c) and (d) A Statement is attached.

Statement

An amount of Rs. 175.00 lakhs has been provided for celebration of the SAARC Year of the Giri Child, 1990. This amount is being utilised for various activities like advocacy and media campaigns; Action Research Projects by 22 Universities in the country on the 'Giri Child and the family' to- identify problems like literacy, education, socialisation, age of marriage, health and nutrition, female infanticide etc; organisation of Baika Shivirs in 250 districts in the country with low literacy indicators and where the outreach of the electronic media is limited; creches attached to schools to enable girl children to leave their younger brothers and sisters in the creches and attend the schools and assistance for strengthening the protective homes set up under the Immoral Traffic Prevention Act. so far an amount of about Rs. 93.00 lakhs has been sanctioned for the programmes on advocacy, Action Research Projects and Balika Shivirs.

Harijans burnt alive at Atola, Bihar

- (a) whether Government's attention has been drawn to the news item appeared in 'The Hindustan Times' dated 5th December, 1990 wherein it was stated that four members of a Harijan family were allegedly burnt alive by landlords at Atola near Hahi village (Patna) on 4th December, 1990;

- (c) whether any arrest has been made in this regard; and
- (d) whether any action is contemplated by Government against the persons found guilty and if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI **SUBODH** KANT SAHAY): (a) The Government have seen the report.

(b) to (d) The incident occurred in a village in Bihar. Maintenance of Public Order which includes registration, investigation, detection and prevention of crime through the police machinery is primarily the responsibility of the State Government, The matter raised in the Ouestion has been brought to the notice of the Government of Bihar for appropriate action.

Development of arborne early warning aircraft at Bangalore centre

590. SHRI KAPIL VERMA; SURYAKANTA SHRIMATI PATIL:

Will the PRIME MINISTER be pleased to

- (a) whether an airborne early warning aircraft has been developed at the Banga lore Centre and whether its maiden flight conducted:
- (b) if so, whether it has been found satisfactory, if so, the details thereof;

- (c) whether some more time and effort is needed to make it ready;
- (d) if so, the stage of development reached;
- (e) when it would be available for production and use; and
- (f) the amount of money spent So far and how much more needed?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI LALIT VIJAY SINGH): (a) and (b) No, Sir. However, under competence development programme in the field of airborne early warning (AEW) technology, an Avro Aircraft modified with structural rotodome has been test-flown. The mission objective was fully met and the flight test was successful.

(c) to (f) Does not arise, as the development and production of airborne early-warning aircraft is not envisaged.

Development and restructure of small scale industry

The workshop was organised only to define the focus of a study proposed *to* be conducted by NCAER as a collaborative effort.
