THE MINISTER OF EXTERNAL AFFAIRS (SHRI VIDYA CHARAN SHUKLA) (a) Government have noted the press reports about the contents of a letter written by the U.S. Ambassador in Pakistan to the so-called President of Pakistan occupied Kashmir, Sardar Abdul Qayyum,

(b) Government have repeatedly reiterated its well-known position that the state of Jammu & Kashmir is an integral part of India.

NRIs returning from the Gulf
