THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI SUBODH KANT SAHAY): (a) to (c) The Prime Minister has held meetings on 7th and 8th December, 1990 in New Delhi with representatives of political parties from Punjab. The meetings were attended by representatives of Congress(I), Akali Dal (Panthic), A. D. (Pheruman), S. A. D. (Longowal), C. P. I., C. P. I. (M), Janta Dal, B. J. P., B. S. P. and Janta Dal (S). Various suggestions were made by the participants.

#### Right to Work

599. SHRI S. S. AHLUWALIA:

Will the PRIME MINISTER be pleased to state:

(a) whether Government have decided to introduce a Constitution Amendment Bill in either House of the Parliament incorporating "Right to employment" as fundamental right therein; and

(b) if so, by when Government propose to introduce such a Bill in the Parliament.

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND THE MINISTER OF STATE IN THE MINISTRY OF WELFARE (SHRI RAMJI LAL SUMAN): (a) and (b) In pursuance of the decision taken at the meeting of National Development Council, a Committee has been set up to examine the legal, operational, organisational and financial aspects of the approach for achieving the goal of right to work.

#### Right to Work as Fundamental Right

600. SHRI RAJ MOHAN GANDHI: Will the PRIME MINISTER be pleased to state:

(a) whether Government proposes to take steps to include the Right to Work as a Fundamental Right and also to make its economic, industrial and educational policies employment-oriented; and

(b) if so, the details thereof?

THE MINISTER OF STATE IN THE PRIME MINISTER'S OFFICE (SHRI KAMAL MORARKA): (a) and (b) The approach to and modalities of operationalising the Right to work are being examined by a Committee of the National Development Council in accordance with the decision of the Council at its meeting held on 11th October, 1990.

The Eighth Plan Approach document proposes employment as the central thrust of the Plan. For this purpose, the Approach suggests that substantial shifts in the pattern of investment in favour of sectors and activities using less capital and more labour per unit of output would be necessary. The basic elements of the strategy are: rapid and geographically diversified growth of agriculture, diversification of agriculture into high value crops, development of appropriate support and policy framework for the growth of non-agricultural activities in rural areas, emphasis on small and decentralised segments of manufacturing sector, large scale programmes of construction, expansion and strengthening of social infrastructure, education and health, particularly in rural areas and reorientation of education to give emphasis to technical and vocational aspects and development of skills, besides greater priority to mass literacy and elementary and secondary education. Details will be incorporated in the Eighth Plan document.

#### Delay in Sea Bird Project at Karver and Ezhimala Naval Academy in Kerala

601. SHRI PARVATHANENI UPENDRA: Will the PRIME MINISTER be pleased to state:

(a) whether two prestigious projects of the Indian Navy viz. the Sea Bird Projects

at Karvar and the Ezhimala Naval Academy in Kerala are likely to be further delayed; and

(b) if so, what are the reasons for the same?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI

LALIT VIJAY SINGH): (a) and (b) Certain slippages have taken place in the implementation of Project Sea Bird at Karvar due to delays in the acquisition of land and rehabilitation of effected families. Construction of Naval Bases are, in the normal course, very long gestation projects and may extend over even longer periods, depending on the availability of resources.

The Naval Academy Project at Ezhimala, on account of the time taken for conducting an Architectural Competition for selection of the Project Architect as well as paucity of resources, has been delayed. Phase I of the Project is now expected to be completed by the end of the current Plan, around 1995. Phase II will be taken up thereafter.

#### **Cable TV Networks**

Cable TV networks being established in different parts of the country. A high level Inter-Departmental Committee has accordingly been constituted by the Government to study various aspects of the establishment of these networks and Dish-Antennae Systems in the country and to make suitable recommendations for the consideration of the Government.

#### **Decline in Growth of Employment opportunities**

(a) whether there has been an alarming decline in the growth of employment opportunities in the country during the last few years; and

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND THE MINISTER OF STATE IN THE MINISTRY OF WELFARE (SHRI RAMJI LAL SUMAN): (a) and (b) According to estimates based on the successive rounds of the National Sample Survey the average annual rate of growth of usual status (principal and subsidiary) employment was 1.55 per cent during the period 1983 to 1987-88 (the latest year for which estimates are available) compared to 2.22 during the period 1977-78 to 1983 and 2.82 per cent during 1972-73 to 1977-78.
