Deaths due to Encephalitis

332. SHRI SHAMIM HASHMI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether it is a fact that hundreds of people have died due to Encephalitis in U. P. Bihar, Assam as reported in 'Assam Tribune' of 16th September, 1990;

(b) if so, the details of deaths caused in each State; and

(c) what steps Government have taken to combat the menace?

THE MINISTER OF HEALTH AND FAMILY WELFARE (PROF. SHAKE-ELUR REHMAN): (a) to (c) The Government has seen the news items reported in the 'Assam Tribune' 16th September, 1990. According to the information received from the State Governments, deaths due to Japanese Encephalitis reported during 1990 are as under: —

Assam	114
Bihar	25
U. P.	67

The following specific steps are being taken by the State Governments to control Japanese Encephalitis;

— Early diagnosis and prompt treatment of Japanese Encephalitis.

Health Education to improve awareness and ensure community participation in the programme for prevention and control of Japanese Encephalitis.

Vector control to prevent transmission through insecticidal spray with appropriate insecticides.

— Vaccination of children, who are more vulnerable for Japanese Encephalitis in areas having high endemicity.

— N. I. V. Pune, NICD, Delhi, S. T. M., Calcutta and All India Instt. of Hygiene & P. H. Calcutta have been involved for epidemiological investigations and viral confirmation.

Target of wind power in 8th Plan 333. SHRI SHAMIM HASHMI: Will the Minister of ENERGY be pleased to state:

(a) whether a target of 500 MW of wind power for the Eighth Plan has been proposed at a National Symposium held at Madurai in October, 1990;

(b) whether an overall target of 3000 MW has also been suggested by the year 2000; and

(c) whether Government have accepted the suggestions specially in the light of shortages of conventional fuels and future needs; if so, the details thereof?

THE MINISTER OF STATE FOR ENERGY (SHRI BABAN RAO DHAKNE): (a) and (b) Yes, Sir.

(c) The wind energy programme is likely to be enlarged during the Eighth Plan. The specific targets will be fixed depending on the 8th Plan allocation to be made for this area.

Drug price fixation by BICP

335. SHRI DHULESHWAR MEENA:
Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

(a) whether the attention has been drawn to the news-item which appeared in the Business Standard Calcutta on 1st November, 1990 under the "BICP Denies Discrepancies in Drug Price Calculations;

(b) what is the role assigned to BICP;

(c) whether it is a fact that the price recommended by BICP are unjustified and pro-producers;

(d) what are the names of drugs where his Ministry found their recommendations unjustified and what steps have been taken to call explanation from BICP;

(e) whether it is a fact that certain instances have come to the notice of his Ministry where market prices of drugs are lower than notified

(f) if so, names of such drugs notified prices of each and market prices and what steps have been taken to reduce the prices?

THE MINISTER OF PETROLEUM AND CHEMICALS AND PARLIAMENTARY AFFAIRS (SHRI SATYA PRAKASH MALAVIYA): (a) Yes, Sir.

(b) Bureau of Industrial Costs and Prices is a recommendatory body assigned with the task of recommending prices of various commodities including drugs from time to time.

(b) No, Sir.

(d) Prices of drugs are fixed by the Government keeping in view all the aspects including the recommendations of the BICP.

(e) Yes, Sir.

(f) Prices fixed by the Government under provisions of Drugs (Prices Control) Order, 1987 are the maximum sale prices and the manufacturers are free to sell the bulk drugs at prices not exceeding the price fixed by the Government. Whenever reports of market prices of a bulk drug being lower than Government fixed price come to the notice of the Government, necessary action is taken in the matter. Price of Analgin has already been reduced on this basis
