THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI LALIT VIJAY SINGH): (a) It is true that Pakistan continues to out-spend India in military expenditure in proportion to every index normally used to measure such expenditure.

(b) and (c) The high level of military spending in Pakistan is a cause of concern to us. However, all necessary measures are being taken to ensure effective defence preparedness.

One rank-one pension for ex-servicemen

Thereafter, discussions were held with the various concerned Deptts/Ministries and a scheme to provide adhoc increase in pensions to Defence personnel, below officer level, who retired before 1-1-1986, was approved by the previous Government on 1st November 1990. This decision is oeing reviewed by the present Government.

Production of light attack helicopters
