(a) whether Government have any proposal under consideration to shift the National Testing Range from Baliapal in Orissa to a place outside the State;

(b) whether Government's attention has been drawn to the Orissa Chief Minister's recent statement that the defence authorities are free to go ahead with the missile programme from the interim Test Range from Chandipur but that the National Test Range should not be located in Orissa; and

(c) if so, what is Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI LALIT VIJAY SINGH): (a) to (c) Government is aware of the views expressed by the Chief Minister, Orissa. Number of other representations have also been received regarding shifting the site of National Range from Baliapal in Orissa. The Government is looking into the matter.
