Starting speed-post service to Nagarcoil in Kanyakumari district

- (a) whether it is a fact that there is a great need for starting Speed-Post service to Nagercoil, an important trade and business centre in Kanyakumari District; and
- (b) if so, the steps taken to start this service as a priority basis?
