## Improved facilities for passengers on Indian airlines Flights

444. SHRIMATI MARGARET ALVA: Will the Minister of CIVIL AVIATION be pleased to state:

- (a) whether Government are considering improved facilities for Passengers on Indian Airlinse flights; and
  - (b) if so, what are the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION (SHRI HARMOHAN DHAWAN): (a) and (b) The following measures have been taken by Indian Airlines to provide improved facilities for passengers on Indian Airlines flights:—

## 1. Reservation:

- (a) Extension of computrised reservation facilities.
  - (b) Increase in the number of passengers sales agents and providing them with computerised reservation facility in a phased manner.
- 2 Dissemination of information:
- (a) Provision of additional telephone lines and auto answering machines at major stations;
- (b) Teletext service on Delhi Doordar-shan.
- (c) Visual display units at major airports.
- 3. Airport facilities:
- (a) Introduction of computerised check in facility at the four base stations and at Hyderabad and Bangalore resulting in reduction in check in time and long queues;
- (b) Free check in facility at Terminal-I at I.G.I. Airport, Delhi and airport terminals at Bombay and Madras;
- (c) Tele check in facility for executive class passengers at Delhi and Bombay Airports; and extending this facility to other base stations in a phased manner:
- (d) Provision of special customer service units and introduction of floor walkers at major airports (departure

lounge) to meet the special needs of passengers.

- 4. Delays/disruptions:
- (a) Monitoring of delays with a view to minimising flight delays:
- (b) in the event of delays/cancellations, provision of hotel accommodation, surface transport, meals, re-routing of tickets, refunds, etc.
- 5. Catering:
- (a) improving the variety and quality of the menus.
- (b) improving the presentation of the menus.
- ... 6. Availability of seats:

Re-induction of the Airbus A-320 fleet in a phased manner will result in considerable improvement in the availability of seats on Indian Airlines flights.
