Pressure to open newer and more effective subjects at plus two stage in Kendriya Vidyalayas

455. SHRI TALARI MANOHAR: SHRIMATI BIJOYA CHAKRA-VARTY:

Will the Minister of HUMAN RE-SOURCE DEVELOPMENT be pleased to state:

- (a) whether it is a fact that All India Kendriya Vidyalaya Teachers As sociation has been pressing for opening of newer and more elective subjects at plus two stage in Kendriya Vidyalayas;
 - (b) if so, what are the details thereof: and
- (c) what is the stand of the Sangathan thereon?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI **BHAGEY** GOBARDHAN): (a) to (c) The All India Kendriya Vidyalaya Teachers' Association (AIKVTA) has requested for introduction of new elective subjects such as Physical Education, Music, JDrawing and Civics at plus two stage. Kendriya Vidyalayas cater to the educational needs of the children of transferable Central Government Employees, including Defence Personnel. Hence, it is necessary to have uniformity in the courses throughout the country. Offering more elective subject at plus 2 level uniformly in all Kendriya Vidyalayas would substantially increase the requirement of funds for additional teachers and class rooms, etc. Keeping in view the resource constraints, the number of new elective subjects has had to be kept restricted.
